NEW BUSINESS:

- A. Steve Bruman BangallWorks & Recreation Capital Campaign Committee has asked about us holding a fundraiser for the Rec Capital Campaign Committee at the library. The Committee will be holding numerous events around town. These will be public fundraising events starting in May and running through October 2022. Ideas TBD. Mark made a motion to make the library available for an event. Vote taken. Passed.
- B. Mark made a motion to transfer \$40,000 from our Money Market Account at the Bank of Millbrook to The Vanguard Total Stock Index. Vote taken. Passed.
- C. Vote to pursue a 414 vote and the amount to ask for. Mark reviewed and explained the entire process in detail. A motion was made to proceed with a petition to raise the amount of taxpayer funds the library would receive from the Town by \$28,400 yearly to a total of \$170,400. Vote taken. Unanimously approved.
- D. Tax Cap Override Resolution. Christa explained and read the specific resolution required for the library board to pass for the 2023 budget. Matter was discussed. Motion made. Vote taken. Unanimously approved.

Whereas, the adoption of the 2023 budget for the Stanford Free Library may require a tax levy increase that exceeds the tax cap imposed by state law as outlined in General Municipal Law Section 3-c adopted in 2011; and

Whereas, General Municipal Law Section 3-c expressly permits the library board to override the tax levy limit by a resolution approved by a vote of sixty percent of qualified board members; now therefore be it

Resolved, that the Board of Trustees of the Stanford Free Library voted and approved to exceed the tax levy limit for 2023 by at least the sixty percent of the board of trustees as required by state law on April 12, 2022.
